Thank you for your request for information which was received on 14 September 2012.

### **Your request**

*1) For the authors of the emails supplied in 465072. (The author and council employees that the author of attached email reports to either directly or indirectly.) Please provide any information held by the Council that shows any payments made in the last 24 months to these individuals excluding salary payments. Please include any information held that shows what these payments were for. I do not need to know the names of any of the individuals.*

*2) For the last 24 months - Please supply details of any payments paid from St George's 106 money for any camera equipment (installation/cameras/wiring/ viewing -recording hardware etc) that has been used by Parking Services. (It is possible that equipment will have been installed under eg "safety" rather than "parking", . so please include these if equipment has been used or is planned to be used by Parking Enforcement/Services.) If no money has been spent on equipment used by Parking Services - I do not require any information on this request.*

*3) Please supply*

- a) information that shows the number of cameras used by Parking Enforcement/ Parking Services in the past 12 months*
- b) The number of cameras that were originally funded by Parking Enforcement/ Parking Services.*
- c) Information that shows the number of cameras that were maintained by Parking Enforcement/ Parking Services in the past 12 months.*
- d) Information that shows any assessment of a pressing public need, before installation of any of the cameras used by Parking Enforcement/ Parking Services in the past 12 months.*

*If the time needed to provide this information exceeds the limits set by the Act, please i) ignore 3a) ii) only show the more recently installed cameras in 3d) iii) choose a later start date than the 24 months requested in 1) and 2) above iv) contact me and I will be happy to discuss simplifying (or cancelling one of more of the 3 request above) to save time or make the searches easier.*

## **Our response**

This request is being handled under the Freedom of Information Act 2000.

I can confirm that the information requested is held by Hammersmith and Fulham. I have enclosed copies of the information that is being released to you.

*1) For the authors of the emails supplied in 465072. Please provide any information held by the Council that shows any payments made in the last 24 months to these individuals excluding salary payments. Please include any information held that shows what these payments were for.*

No such payments have been made.

*2) For the last 24 months - Please supply details of any payments paid from St George's 106 money for any camera equipment (installation/cameras/wiring/viewing-recording hardware etc) that has been used by Parking Services.*

The camera funded located at Imperial Road/Harwood Terrace was funded by way of a s106 contribution. The camera was installed in April 2011, costing £11,065 for installation and a further £3,161 for the associated signage. No s106 money has been spent on maintenance of the camera.

*3) Please supply*

*a) information that shows the number of cameras used by Parking Enforcement/ Parking Services in the past 12 months*

Please see the attached spreadsheet (486123), which was recently disclosed in response to a similar request for information. The spreadsheet confirms the location of all CCTV cameras and the contraventions that can be enforced by each camera.

*b) The number of cameras that were originally funded by Parking Enforcement/ Parking Services.*

*c) Information that shows the number of cameras that were maintained by Parking Enforcement/ Parking Services in the past 12 months.*

The cost of camera maintenance is shared by Parking Services and Public Safety with both services contributing to the costs. Therefore no cameras were maintained by Parking Services within the past 12 months.

We do not hold this information.
